## Attention Staffing Companies Doing Business in Ohio: Sales Tax on Employment Services Repealed

Effective October 1, 2021, employment services are no longer subjected to sales taxes in Ohio. If your staffing company operates in Ohio, be prepared to update your invoices as of October 1st to reflect this change. If TRICOM completes your invoicing, this change will be automatically implemented. Please speak to your TRICOM accounting representative with any questions.
