Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. What we do	
How does Tricom protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does Tricom collect my personal information?	<ul> <li>We collect your personal information, for example, when you</li> <li>apply for a loan or give us your employment history</li> <li>give us your income information or provide account information</li> <li>give us your contact information</li> <li>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</li> </ul>
Why can't I limit all sharing?	<ul> <li>Federal law gives you the right to limit only</li> <li>sharing for affiliates' everyday business purposes—information about your creditworthiness</li> <li>affiliates from using your information to market to you</li> <li>sharing for non affiliates to market to you</li> <li>State laws and individual companies may give you additional rights to limit sharing.
