Did You Know? Federal Tax Filing and Payment Due Date Postponed

Early in the week of March 16, the IRS announced that payment deadlines for federal taxes would be extended until July 15, 2020. At that time, the deadline to file federal taxes was still April 15, 2020.

Friday, March 20, Treasury Director Steve Mnuchin announced that the federal tax filing deadline was extended to July 15, 2020, as well.

In addition, the IRS has temporarily closed all Taxpayer Assistance Centers and discontinued face-to-face service throughout the country. The IRS will continue to process tax returns, issue refunds and help taxpayers to the greatest extent possible.
