Over \$2,500,000 (Zone 1)	.895% (.00895)
Over \$2,500,000 (Zone 2)	.635% (.00635)

Zone 1 includes the counties of New York (Manhattan), Bronx, Kings (Brooklyn), Queens, Richmond (Staten Island)

Zone 2 includes the counties of Rockland, Nassau, Suffolk, Orange, Putnam, Dutchess, and Westchester.
